1) Invoicing address and the correct invoicing information to be included

Please check that you have the right invoicing address in your customer register. See table under point 2.

Correct information to be included on the invoice:

- The correct legal entity in DNB
- DNB reference (Full name or e-mail address to the buyer in DNB)
 - \circ ~ Invoices with no reference will be returned/not processed
 - E-mail address to the buyer in DNB must be filled out in "BuyerReference" (in the XML-file). See page 4.
- The invoice must be marked with DNBs order number or contract number (If applicable)
- Contact information of supplier: e-mail, contact person and telephone number.

Furthermore, invoices must include information according to the Norwegian Bookkeeping Act (bokføringsloven)
